## We are licensed Mississippi State medical doctors & U.S. colleagues, all actively engaged in clinical practice. We come to you with the following urgent health concerns:

- ➤ We observe a medical crisis occurring increasing disability and death in Mississippi caused directly by mRNA vaccines produced by Moderna and Pfizer.
- We ask for transparent data to verify the full scope of disability and death from these mRNA vaccines.
- We ask that the administration of further Covid-19 mRNA vaccines to the population be stopped immediately pending further investigation. This is a man-made medical emergency.
